

River Canyon Total Return Bond Fund Q3 2020 Commentary

During the third quarter ended September 30, 2020, the River Canyon Total Return Bond Fund (RCTIX) returned 3.46% net of fees vs. 0.62% return of the Bloomberg Barclays US Aggregate Bond Index. Over the most recent three year and five-year periods, RCTIX returned 6.08% and 5.84% net of fees, while the index returned 5.24% and 4.18% respectively.

Market Commentary and Total Return of Selected Bloomberg Indices and Subsectors

The third quarter was a continuation of the second-quarter rebound in risk assets as stable central bank support and tentative re-opening plans moved forward in many countries as the world began to emerge from COVID-19 lockdowns. The Federal Reserve continued their purchases of investment-grade corporate bonds, but significantly tapered their purchases towards the end of the quarter, falling from \$2.3B in July to \$280mm in September. Most fixed income sectors generated positive returns driven by declining Treasury yields and tightening credit spreads. The pandemic continues to impact nearly all aspects of the economy, and with the lack of another stimulus, there remains significant uncertainty in the economic path to recovery.



We entered the quarter with the portfolio positioned in high-quality structured credit securities, anchored by an allocation to Agency RMBS, seasoned Non-Agency RMBS, and short duration floating rate super-senior securities. The continued mark to market recovery of the fund's holdings and some credit spread tightening drove Q3 performance. Strong third quarter inflows allowed us to purchase several attractively priced ABS, CMBS, Mortgage REIT, and corporate securities. With interest rates near zero, structured credit sectors offer a relatively safe, higher-yielding alternative to traditional core bonds. As of September 30, 2020, RCTIX generated a higher yield than its benchmark while maintaining a shorter duration position.

The Fund continues to maintain a broadly diversified allocation with a concentration of higher quality, liquid structured credit securities. In an environment of low yields and the need for investors to allocate to safe, higher yielding securities, areas of opportunity include Non-Agency RMBS, CLOs, Aircraft/Auto ABS, CMBS, Esoteric ABS, and corporate credit securities. While cautious on these sectors as a whole, we identified and purchased several securities that fit the funds long term investment profile of investing in securities that provide asymmetric reward for calculated risk. We are carefully targeting securities that offer attractive yields and believe will be resilient in a wide range of economic and interest rate scenarios. We continue to exercise the same investment discipline we have always exhibited and remain focused on generating strong absolute and risk-adjusted returns for our investors.

Bloomberg Barclays U.S. Aggregate Bond Index: This index is comprised of approximately 6000 publicly traded bonds including U.S. Government, mortgage-backed, corporate, and Yankee bonds with an average maturity of approximately 10 years.

U.S. Corporate – Investment Grade: This index is the Corporate component of the U.S. Credit index. It includes publicly issued U.S. corporate and specified foreign debentures and secured notes that meet the specified maturity, liquidity, and quality requirements. To qualify, bonds must be SEC-registered.

CMBS (Commercial Mortgage-Backed Securities): This index is the CMBS component of the U.S. Aggregate index. The Bloomberg Barclays CMBS ERISA-Eligible Index is the ERISA-eligible component of the Bloomberg Barclays CMBS Index. This index, which includes investment grade securities that are ERISA eligible under the underwriter's exemption, is the only CMBS sector that is included in the U.S. Aggregate Index.

US MBS (Mortgage-Backed Securities): This index is the U.S. MBS component of the U.S. Aggregate index. The MBS Index covers the mortgage-backed pass-through securities of Ginnie Mae (GNMA), Fannie Mae (FNMA), and Freddie Mac (FHLMC). The US Agency MBS Index is formed by grouping the universe of over 600,000 individual fixed rate MBS pools into approximately 3,500 generic aggregates.

ABS (Asset-Backed Securities): This index is the ABS component of the U.S. Aggregate index. The ABS index has three subsectors: credit and charge cards, autos, and utility. The index includes pass-through, bullet, and controlled amortization structures. The ABS Index includes only the senior class of each ABS issue and the ERISA-eligible B and C tranche.

U.S. High Yield: The Bloomberg Barclays U.S. High Yield Index covers the universe of fixed rate, non-investment grade debt. Eurobonds and debt issues from countries designated as emerging markets (sovereign rating of Baa1/BBB+/BBB+ and below using the middle of Moody's, S&P, and Fitch) are excluded, but Canadian and global bonds (SEC registered) of issuers in non-EMG countries are included. Original issue zeroes, step-up coupon structures, 144-As and pay-in-kind bonds (PIKs, as of October 1, 2009) are also included. One cannot directly invest in an index.
