Executive Summary - RCTIX

Portfolio Performance

The River Canyon Total Return Bond Fund navigated the sharp rise in interest rates, returning 2.75% in the quarter, outperforming its index by 612 basis points as the Bloomberg Barclays Aggregate Bond Index returned -3.37%. Agency floating rate exposure was the primary contributor, along with shorter duration structured credit positions. US Treasury positions detracted as the 10-year treasury rate rose 83 basis points.

- Exposure to Agency Interest Only securities was the primary contributor to the fund's performance in the quarter as interest rates rose and the curve steepened. We began building this position in mid-2020 as 10-year yields fell to record levels and the risk-reward in this sector of the structured credit markets became substantially skewed in our view. We targeted specific collateral backing these securities to manage downside risk in the event rates fell further.
- Puerto Rico Municipals exposure was the next largest contributor. These securities benefited as the Commonwealth and creditors made progress on the bankruptcy restructuring plan.
- Single Asset, new issue CMBS also contributed to the fund's performance. Although cautious overall on commercial real estate, our security specific approach to CMBS has found value in securities where we have increased transparency to underwrite the collateral structure. This part of the portfolio has been benefitting from tightening spreads and positive reopening trends. Initiated at close to distressed levels in mid-2020, these securities are an excellent example of the fund's ability to source and underwrite securities offering attractive absolute and relative value.
- Non-Agency RMBS focused primarily in the senior part of the capital structure, benefited from tighter spreads and continued improvement in credit performance and housing market conditions.

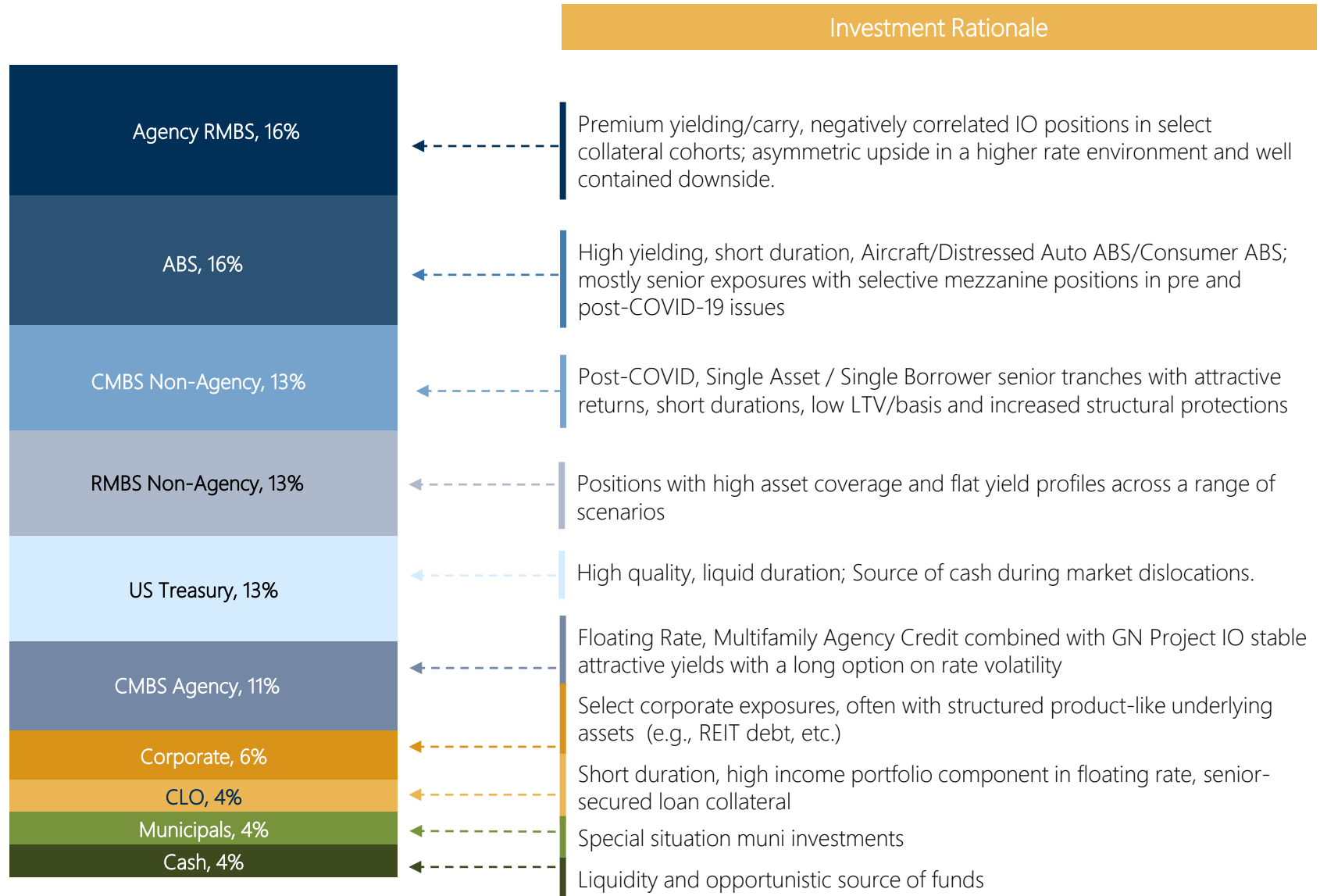

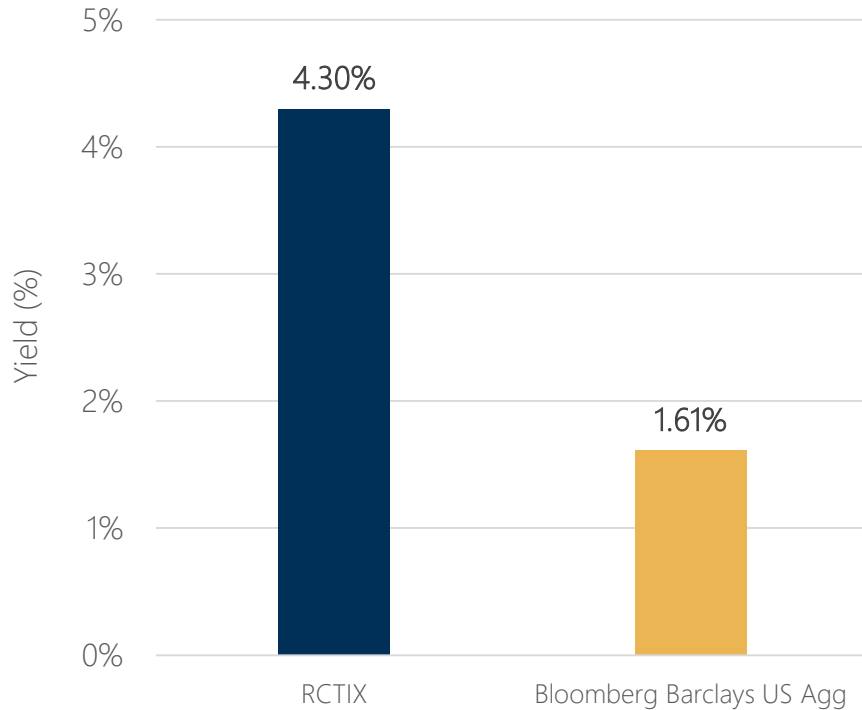

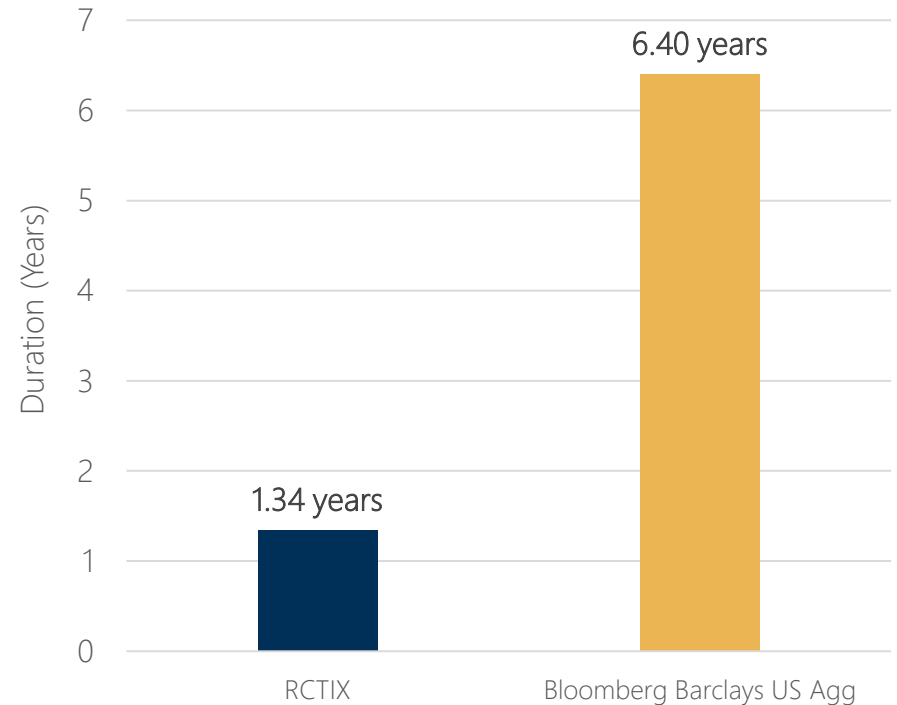
Higher Yield, Lower Duration¹

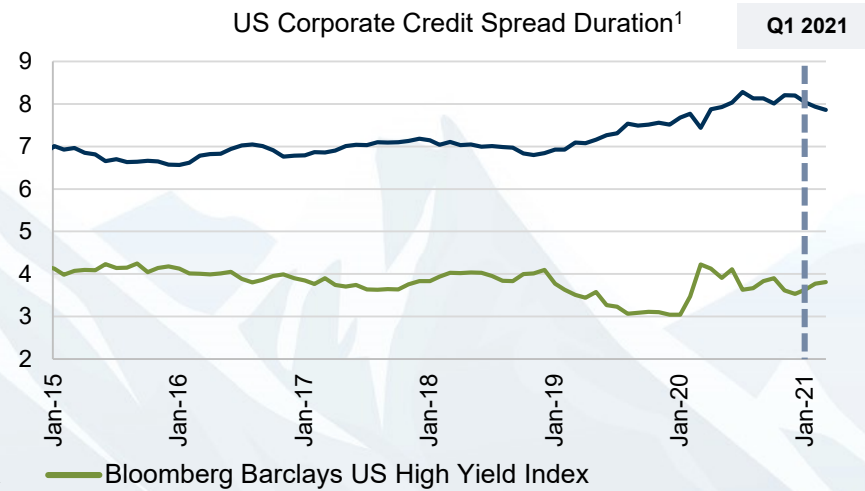

Fixed Income Market Recap

Most fixed income sectors produced negative returns during the first quarter. The BBAG returned -3.37%, its worst quarterly return since 1981, while the US Investment Grade Index and US High Yield Index returned -4.65% and .85%. The yield curve steepened as the 10-year Treasury increased 83 basis points to 1.74%. Credit spreads tightened across most sectors during the quarter, with High Yield spreads(-50bps) tightening the most as spread durations remained near highs.

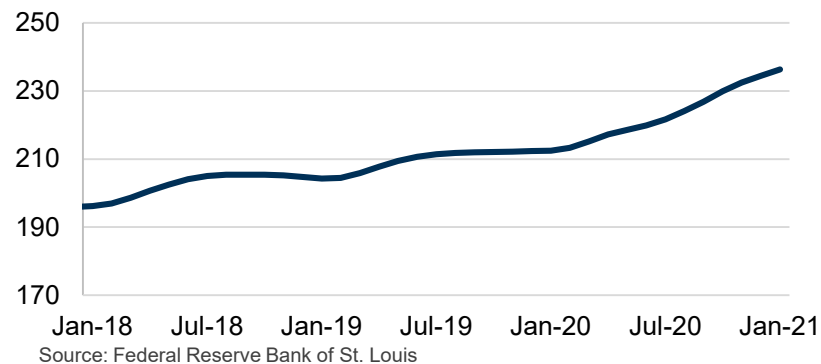
Inflation expectations and home prices move higher

Expectations for a sustained global recovery continued to grow in Q1 against a backdrop of improving economic data, increasing vaccinations, significant fiscal support, and accommodative monetary policy. The Fed continued their \$120B in QE purchases and importantly indicated they are shelving their pre-emptive inflation response function. Public debt levels and the Fed's balance ended the quarter at record levels. Home prices continued to rise, supported by limited supply, low mortgage rates, and higher lumber prices.

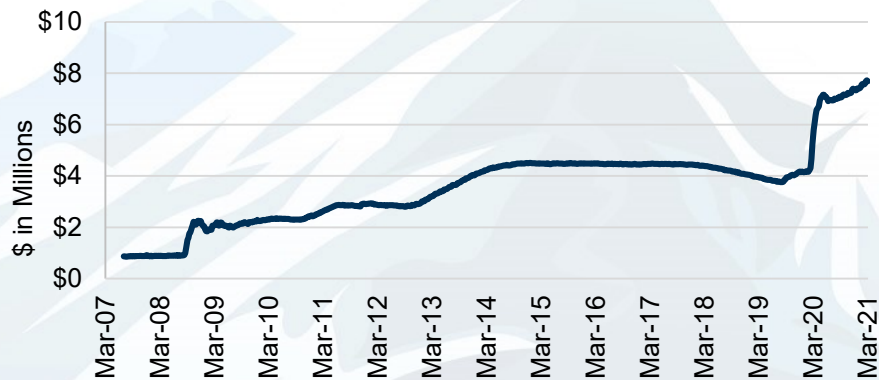
5-Year, 5-Year Forward Inflation Expectation Rate¹



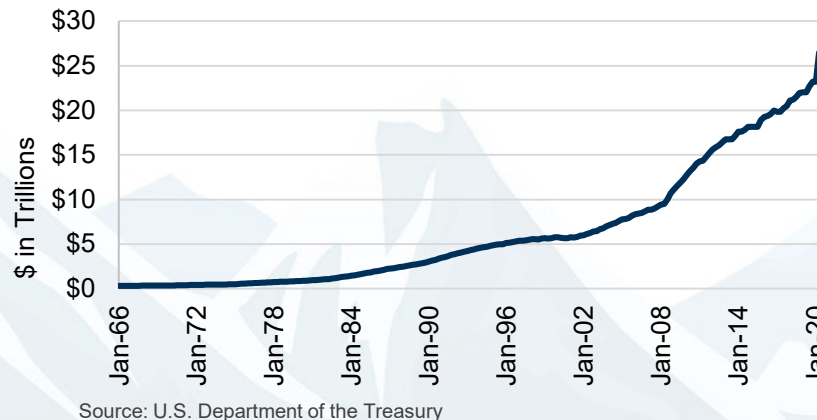
Case-Shiller National Home Price Index¹

Principal Investment Risks

Investment Risks It is important to note that the Fund is not guaranteed by the U.S. Government.
